

### What is an Advanced Health Directive (AHD)?

At some point in the future, you may be unable to make decisions about your health care, even temporarily. This might be due to an accident, dementia, a stroke or a mental illness. In such circumstances, your AHD would effectively become your voice.

An advance health directive allows you to:

Authority

- · give directions about your future health care
- make your wishes known and give health professionals direction about the treatment you want
- appoint someone you trust (an attorney) to make decisions about health care on your behalf.

## Do you have any plans for organ donation that need placing on the formal record?

The Australian Organ Donor Register is the only national register for people to record their decision about becoming an organ and tissue donor for transplantation after death. Registering is voluntary and people have complete choice over which organs and tissues they wish to donate. If a person does not want to become an organ and tissue donor, they can register their decision not to donate on the Donor Register.
